

Public records released by the City of Tucson (copy attached) memorialize the ongoing
and regular destruction of hundreds of confiscated and forfeited firearms that appear to
be valuable, in working condition, and lawful to possess under Arizona and federal law.
It appears that the Tucson Police Department regularly approves requests to destroy such
firearms notwithstanding Arizona statutes that require the City to sell them.
